

What can be done with the documents I upload to DI-fusion?

Choose the terms of use of the documents you upload to DI-fusion:

- Terms of use defined by ULB Any person who browses DI-fusion through the internet or ULB's intranet may read, download, and copy on paper or any other support the article or excerpts from other works hosted on DI-fusion, for private use or to illustrate teaching or scientific research materials.

The terms of use of the content hosted on DI-fusion are [available from DI-fusion](#) homepage.

- You may grant more extensive rights by choosing a Creative Commons license. This is possible only if you did not transfer your copyright. See <https://creativecommons.org/>

Why must ULB also be granted a non-exclusive licence to copy and share documents uploaded to DI-fusion?

In order for ULB to disseminate the documents you upload to DI-fusion according to the terms you have set (open access or restricted to ULB's intranet), you must give it permission.

This means that every time you upload a document to DI-fusion, you must agree to [the non-exclusive licence to copy and share](#). This licence does not involve a transfer of copyright; you are still free to use your work on any media of your choice. You also guarantee that you have the right to grant this licence to the University, and that you have obtained the necessary permissions from any third parties that may have copyrights on images or other parts of your publication.

easy COPYRIGHT guide

Practical guide for ULB researchers and teachers

you have **the RIGHT to upload to DI-fusion**,
regardless of the contract you have signed with the publisher :

Scientific article:

- postprint** (final manuscript) in Open Access after a period of
 - 6 months after publication in science, technology and medicine ;
 - 12 months in social sciences and humanities.
- upload** your postprint upon acceptance for publication and **specify** the end date of the embargo period. The file will automatically become accessible to the public after that date.

publisher's version in restricted access [ULB Intranet]

Book chapter, conference paper:

publisher's version in restricted access [ULB Intranet]

Monographs and other types of document:

publisher's version in private access

Versions of a publication:

- Preprint:** your manuscript unpublished or submitted for publication
- Postprint:** final manuscript after peer review, as approved for publication in a journal but before being laid out by the publisher
- Published version:** publisher's version, as published with the journal's layout (usually a PDF file).


Access to documents uploaded to DI-fusion:

- Open access:** your document is available to anyone on the internet
- Restricted access [ULB Intranet]:** access to your document is restricted to members of the ULB community, by login to the ULB intranet
- Private access:** your document is available only to yourself (personal archiving)
- Embargo period:** period during which the publication cannot be available on open access in DI-fusion.

What am I legally allowed to deposit in DI-fusion?

You have not signed any publishing contract?


 You may upload any version of your work in open access on the internet, to DI-fusion or any other website or platform.

You have published before 1993?


 You may upload a scanned version of your work (article, book chapter, contribution to a conference, book) in open access on the internet, under Article XI.167 §1 of the Code of Economic Law.

Note: if the publishing contract was renegotiated after 1993, check the new distribution and sharing conditions (see hereunder).


You have published after 1993 a scientific article?

-  Belgian law entitles you to **RETAIN** the right to:
- grant **open access** (free internet access) to the **manuscript** (preprint or postprint version) of any article published in a periodical, stemming from research that has received at least half of its funding from public sources
 - after a **period** of
 - 12 months after publication for social sciences and humanities
 - 6 months for other sciences,
 - regardless of the contract signed with the publisher,
 - as far as the source of the first publication is mentioned,
 - including articles published before the relevant law came into effect (15-09-2018).


This is an imperative right; it applies regardless of the law under which the contract was signed, provided that there is a connecting factor located in Belgium. ([Code of Economic Law, Book XI, article XI.196 §2.1](#))

 You also have the right to make the publisher's version of your article available in restricted access (ULB intranet) for the purposes of teaching and scientific research (as per the Code of Economic Law, Article XI.191/1, which provides for an exception for teaching and scientific research).


You have published after 1993 another type of publication (book chapter, book, conference paper...)?

 Regardless of the contract you have signed, you have the right to upload your work in restricted access (ULB intranet) for the purposes of teaching and scientific research, provided this does not interfere with its regular use (as per the Code of Economic Law, Article XI.191/1, which provides for an exception for teaching and scientific research). If your work is a book, check that it is no longer available for purchase.

Books published by Editions de l'Université de Bruxelles (ÉUB)

 Every author of an article featured in a journal published by the ÉUB, or of a chapter featured in an edited collection released by the ÉUB is allowed to post the final version (**publisher's version**) of their article/chapter online **in open access** on a personal webpage, the website of their research unit and/or their open institutional repository (DI-fusion at ULB), as well as any other not-for-profit archive **immediately after publication** (without embargo).

In any case

 You may upload the **publisher's version** of your work in **private access** (accessible only to yourself) for personal and institutional archiving. Benefits: a single and continued point of access to all your publications, wherever you are, and backup managed by ULB's libraries.

What am I mandated to deposit in DI-fusion?

Any researcher who has a contractual or statutory link with the University is required:

- to **input** the full list of their publications into DI-fusion in order to create their official list of publications at ULB;
- to **upload the full text** of their publications to DI-fusion (author's final manuscript as approved for publication [postprint] or publisher's version) immediately upon acceptance for publication;
- to **make the full text** of their publications available to the public in **open access**, immediately or after a period prescribed by the publisher, it being understood that **for any publication released from 14 September 2018 onwards in a periodical** published at least once a year, and which is the result of a research during which the author was affiliated with the ULB or with another higher education institution of the Wallonia-Brussels Federation, this period may not exceed 6 months after publications for science, technology, and medicine, or 12 months for social sciences and humanities.

This Open Access policy of the University was updated by the Academic Board on July 9, 2018 and accounts for the provisions of the decree of the Wallonia-Brussels Federation "[Décret visant à l'établissement d'une politique de libre accès aux publications scientifiques \(open access\)](#)"
